T4W in all the classrooms from K-6 with a focus that all classes will teach in this style as well as starting instructional reading to help our students succeed.

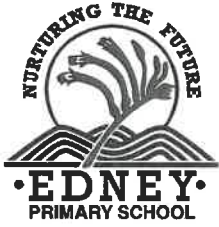
Premiers Reading Challenge is happening across the school. Simultaneous story time happened a week ago and was a great success
