#### **Discuss Review and Approve Proposed school Budget**

Karina presented the proposed school budget. 70% of our revenue charges come from Student Centred funding. Cash carried forward is the next biggest amount. A small percentage comes from Voluntary contributions and there is a small amount for other revenue.

Major Expenditure is utilities, facilities and maintenance, followed by curriculum and student services. There is an amount of money put into reserve for replacement of items such as furniture. There are some funds provided from Regional office for the Network which is used to run the Darling Range Learning Community. Lease payments are for computers and photocopiers.

The agreement is complex and states that if there is damage or unlawful behaviour the Principal can terminate the agreement. The agreements help to generate a positive reputation within the community and so far the relationships have been positive. Next year Karina will present to the board a Community use agreement. Currently there is a judo club, a basketball club and a junior netball club using the facilities.
