

### **Public School Review**

- Aaron presented the Public School Review. Traditionally schools were reviewed every year

   the director would come and visit. Some time ago they decided that they would leave
   the schools that do the right thing alone and visit the schools that were not and audit them.
- When Independent Public schools program started, to balance the autonomy given to IPS schools, they were required to be reviewed by Education Services. When we came on board as an Independent PS, we were required to write a plan and be reviewed at the end of 3 years. However the Department has changed the process again and have introduced the Public School Review process which involves each school being reviewed every 3 years. Edney PS will be reviewed in Term 3, 2021.

- The school enters data and our self-assessment into the assessment tool and the review panel look at this data and then come out to review the school. The Department of Education has access to all of our data (eg Attendance, NAPLAN) all of the time.
- Then the panel writes a review and provides the school with a report.
